CONSTITUTION & BYLAWS

ARTICLE ONE – NAME AND OBJECT

The name of the club shall be the Wawashkamo Golf Club. The object of the Club is to engage in the sport of Golf and other social enjoyments.

ARTICLE TWO – DIRECTORS AND OFFICERS

Section 1. The Management and control of the affairs and property of this Club shall be invested in a Board of up to 12 Directors, who shall be elected at the Annual Meeting of the Club, and shall hold office for a three year term.

Section 2. The President and Secretary may jointly elect a candidate provisionally to membership, such candidate to be definitively voted in by the Board at its next meeting thereafter.

Section 3. The Board shall have power to appoint any committee from the membership it shall deem necessary.

Section 4. The officers of the Club shall be a President, Vice-President, Secretary, and Treasurer. They shall be elected by the Board from among its Members, and shall hold office for one year and until their successors have been elected and have qualified.

Section 5. The President, or if absent, the Vice President, shall preside at all meetings of the Club and the Board of Directors, and shall administer the Club, its properties, and all contractual arrangements of the Club. If both the President and Vice-President be absent from any meeting, the Members present may elect a presiding officer.

Section 6. The Secretary shall keep the records of the meetings of the Club and the Board of Directors, and the list of Members, and shall perform such other duties as may, from time to time, be fixed by the Board. The President shall mail notices of all meetings of the Club and of the Board to the members thereof, as provided by the Bylaws, and shall conduct correspondence.

Section 7. The Treasurer shall collect and disburse funds as directed by the Board and shall keep the accounts in books belonging to the Club. Books shall at all times be open to the inspection of the Board of Directors, to whom shall be made an Annual Report in writing of the money received and paid out, and the amount of funds on hand. The annual financial report will be made available to the general membership following the approval

of the Board of Directors. Notification of the availability shall be no later than June 1 of the following year.

Section 8. Vacancies in the board of Directors shall be filled by the Board.

Section 9. The officers of the Club shall constitute an Executive Board to manage and direct the day-to-day operation of the Club. The responsibility for the election of officers, the appointment of committees and all policy decisions will be reserved to the Board of Directors, to which the Executive Board is responsible.

ARTICLE THREE – MEETINGS

Section 1. The Annual Meeting of the Club shall be held before Labor Day of each year, at such hour and place as the Directors shall designate.

Section 2. Special meetings may be called by the President on at least three (3) days' notice to all members, for the transaction of such business as may be stated in the notice. Such meetings must be called on the request of five members, in writing, to the President, or may be called by the President on his own initiative.

Section 3. Fifteen percent (15%) of the Members of the Club shall constitute a quorum for the transaction of business at any meeting of the Club.

Section 4. The Board of Directors may hold such meetings as they deem fit upon notice to each Member thereof.

Section 5. Fifty one percent (51%) of the Board of Directors shall constitute a quorum of the Board.

ARTICLE FOUR – MEMBERSHIP

Section 1. The categories of membership are (1) regular (2) associate (3) honorary and (4) booster.

Section 2. Regular members only will be eligible for voting rights. The number of Regular members shall be set by the board. Non-residents of Mackinac Island are eligible for regular membership, however their total may never exceed twenty five(25%) of the existing membership.

Section 3. Associate membership shall be available to individuals between the ages of twenty three (23) and thirty five (35) years of age who are children of members. At age thirty five (35) they may become regular members without paying any initiation fee.

Section 4. Honorary members may be (1) elected to such membership by the unanimous vote of the Board of Directors in recognition of extraordinary services to the Club, or (2)

may be the State of Michigan Governors or MISPC members during their term of office. Such Members have all the privileges of Members except voting.

Section 5. Booster membership shall be promotional in nature and available to anyone interested in maintaining and sustaining Wawashkamo Golf Club. The Board of Directors shall establish requirements and Booster membership.

Section 6. Approved applications for Regular, Associate and Honorary membership must be ratified by the Board of Directors, in session.

Section 7. No greens fees need to be paid by Members.

Section 8. The Board of Directors shall have the power to fix the amount of the annual dues and all fees to be paid by players, and to assess the regular members whenever the needs of the Club may so require. All dues are to be paid by March 1.

ARTICLE FIVE – COMMITTEES

Section 1. The Board of Directors shall appoint standing and ad hoc committees as necessary, on the recommendation of the President.

Section 2. Standing committees may include: Budget and Finance, Equipment and Grounds, Membership, Nominations, Social, Tournaments, and Publicity.

Section 3. Committee appointments of the Board will be announced at the Annual Membership Meeting, to be effective the following year. Appointments are for one year.

Section 4. All committees are responsible to the Board of Directors.

ARTICLE SIX – RESIGNATION AND EXPULSION

Section 1. Resignations shall be in writing.

Section 2. No resignations of the membership shall be accepted until all dues and charges against the member have been paid, and all Club property has been returned.

Section 3. A Member may be expelled for misconduct by a unanimous vote of the Board of Directors.

ARTICLE SEVEN – AMENDMENTS

Section 1. Every amendment of the Bylaws of the Club shall first be presented in writing to the Board of Directors, and may be acted upon at any subsequent meeting of the Club.

Section 2. A two-thirds (2/3) majority of the Members present at the Annual Meeting shall be required to amend these Bylaws; prior notification shall be given.

ARTICLE EIGHT – MISCELLANEOUS

In the absence of any other applicable rule or topic, that included in Robert's Rules of Order shall apply.

Member Golf Play Rules

1. Members need not be present when house guests play, but members should contact the pro shop to set up all tee times. House guests are defined as all guests and family visiting for a short stay on Mackinac Island.
2. All members should call the pro shop to set up tee times for themselves and check in at the desk before playing.
3. Club memberships may be transferred by approval of the Board when cottages are passed on to a family member.
4. Dues and initiation fees shall be determined by the Board and shall be paid by March 1st. All club dues and fees shall be paid prior to any Club usage.
5. Tournaments listed below shall be open to all Club members with exceptions outlined in tournament rules.
6. New member initiation fee is \$350 effective as of 2011. No initiation fee is required for an Associate Member. No initiation fee is required if an Associate Member upgrades his/her membership.
7. Non-golfing members and their guests will pay greens fees at a reduced rate.
